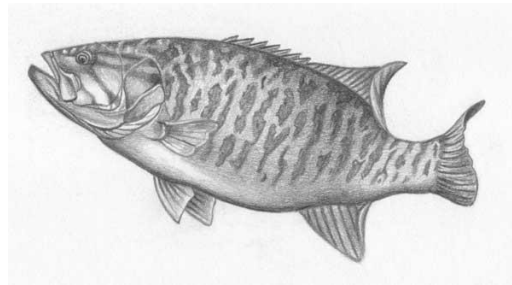

## Rules

1. Must follow all state and local laws
2. Must wear lifejacket when the gasoline powered engine is running (except in No Wake Zones)
3. Only artificial lures may be used, no live bait or trolling
4. 5 fish limit
5. Ties = money split evenly (also ties will occupy two spots, ex. Tie for first then 1<sup>st</sup> and 2<sup>nd</sup> place winnings are split between the two teams and the next team will get the 3<sup>rd</sup> place winnings, etc.)
6. Smallmouth and Largemouth bass may be weighed
7. .25 pound deduction per dead fish (4 oz)
8. 1 pound deduction per minute you are late to weigh-in
9. Short fish brought to the scale will result in the loss of that fish plus 1 lb
10. All bass must be released after weigh-in
11. All protests must be made within 5 minutes of concluding the weigh-in
12. Payback is based on 1 place for every 4 paid boats
13. In the case of a protest, all decisions of the tournament director plus a committee of 2 other fishermen/women are final

1. **Liability Release.** In signing this agreement, I hereby release 2014 Clear H<sub>2</sub>O Tackle Opens officers, agents, employees and sponsors from any and all damages, claims, demands, costs or expenses relating to injury of any persons or damage to any property which I may sustain or which I may cause by reason of participating in or in connection with this or any other 2014 Clear H<sub>2</sub>O Tackle Opens.

2. **Covenant Not To Sue And Waiver Of Subrogation.** I further agree that I will never sue 2014 Clear H<sub>2</sub>O Tackle Opens for damages on account of any injury or damage that I suffer or cause whether known now or which may develop in the future in connection with this or any other 2014 Clear H<sub>2</sub>O Tackle Opens. I expressly agree to indemnify and hold 2014 Clear H<sub>2</sub>O Tackle Opens harmless from any liability whatsoever, including court cost and attorney fees arising with respect to such actions. I understand that in waiving my rights to sue 2014 Clear H<sub>2</sub>O Tackle Opens, I also am waiving the rights of recovery from 2014 Clear H<sub>2</sub>O Tackle Opens of my insurance carrier for any claims they may pay on my behalf. I further understand that by signing this agreement, I waive any rights my heirs or relatives have or may have to sue 2014 Clear H<sub>2</sub>O Tackle Opens for liability.

3. **Verification of Liability Insurance.** I further state that I am a current member of 2014 Clear H<sub>2</sub>O Tackle Opens and that I maintain liability insurance on the boat I will use in any 2014 Clear H<sub>2</sub>O Tackle Opens.

4. **Construction.** If this agreement and the release, covenant, and waivers contained herein are found by any court to be overly broad in any manner, I ask the court to interpret it as broadly as possible.
